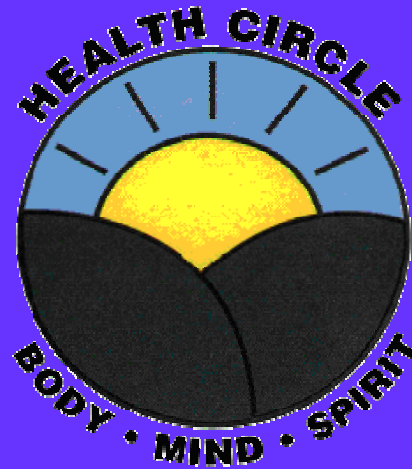

Special Programs and Procedures

- Cosmetics procedures including hair removal, skin repair and rejuvenation in the safety, privacy and friendliness of the neighborhood family doctor
- Physician supervised weight loss program. Initial fee of \$95 for the first month includes exam, program book, and 2 or more office visits. Fee thereafter is \$65 per month for 2 or more office visits. Cost of medication if prescribed is extra.
- Vaccine program provides free vaccines to children. A \$10 fee applies which covers all required vaccines. A required school or sports physical exam is \$80.

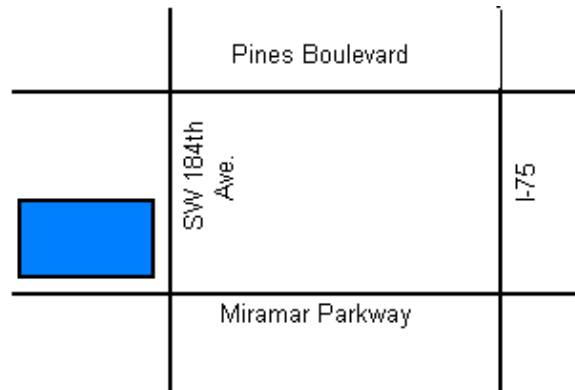
We are located in the Shops at Sunset Lakes, sit of the new Publix, on Miramar Parkway just west of SW 184th Avenue.
